

TRANSPORT EMERGENCY CARD - Road Transport

In accordance with SANS 10232-4

PROPER SHIPPING NAME

ENVIRONMENTALLY HAZARDOUS SUBSTANCE; SOLID; N.O.S.

APPEARANCE

Powder; Grey-yellow; Perceptible odour

DANGER

May cause an allergic skin reaction. Suspected of causing cancer. May damage the unborn child. May cause damage to organs through prolonged or repeated exposure. Very toxic to aquatic life with long lasting effects.

PERSONAL PROTECTIVE EQUIPMENT

Protective goggles or face shield. Protective gloves. Protective shoes. Eyewash bottle with clean water.

EMERGENCY RESPONSE EQUIPMENT

Chemical protective clothing that is specially recommended by the manufacturer. Shovel.

DRIVER FIRST ACTIONS - Contact emergency services. Keep upwind. No smoking. Keep unauthorized personnel away.

DRIVER SPECIAL/ADDITIONAL ACTIONS - Stop leak if you can do it without risk. Prevent dust cloud. Avoid inhalation of dust. Prevent entry into waterways, sewers, basements or confined areas.

DRIVER ACTIONS IN CASE OF FIRE - Move containers from fire area if you can do it without risk. Dry chemical, CO₂, or regular foam. Do not scatter spilled material with high-pressure water streams.

FIRST AID

Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. In case of contact with material; immediately flush skin or eyes (or both) with running water for at least 20 minutes. Give artificial respiration if victim is not breathing. Move victim to fresh air. Remove and isolate contaminated clothing and shoes.

Fire may produce irritating, corrosive and/or toxic gases. Some liquids produce vapours that may cause dizziness or suffocation.
